

To begin the filing process, the user will enter the docket number of the case and click the Search button.

From the Select Document Type screen, the user will complete the following steps:

1. Select the Filing Type as: Miscellaneous Documents
2. Select the Filing Description as: Notice of Settlement

Note: The system will display an information notice informing the user that a template will be created.

3. The user will then click the Continue button.

Select Filer/Adversary

1. The user will select the Filer.
2. The user will select the Adversary.
3. The user will then click the Continue button.





