NON-TRAFFIC VIOLATIONS

A. BOATING VIOLATIONS

1. REGULATION, REGISTRATION AND OPERATION OF VESSELS - STATUTES

Note: Certain violations of Title 12 (New Jersey Statutes), each of those matters listed below with a Payable Amount of \$49.00, require an enhanced penalty for a **second or subsequent** offense (N.J.S.A. 12:7-51). Law enforcement will check the “court appearance” block if the officer believes that the person charged may be a second or subsequent offender. If the “court appearance” block is not checked, then the person charged should be considered a first offender and may, therefore, choose to plead guilty without a court appearance and pay the prescribed amount. Violations that have a payable amount greater than \$49.00 are not subject to increased penalties for second or subsequent offenses.
