The automated phone system is available 24 hours a day, 7 days a week to obtain case information such as payments, case balance, court date information, etc.

If you are the CP, NCP or Authorized 3rd Party on a child support case – Say “Access my Case”
For Employer, Agency Worker, Attorney, and all other calls – Say “Help Me with Something Else”
