Essex County Historic Courthouse
Cases Scheduled for Monday, March 12, 2012 Relocated

Due to the services for late-U.S. Rep. Donald M. Payne, all Superior Court cases scheduled to be heard on Monday, March 12 in the Essex County Historic Courthouse in Newark have been relocated to the Veterans Courthouse at 50 W. Market St., and the Hall of Records at 465 Dr. Martin Luther King Blvd.

Attorneys, litigants and others who were to appear at the Historic Courthouse should report to the Veterans Courthouse and Hall of Records according to the schedule below.

Although the Historic Courthouse will reopen to the public at 9 a.m. on Tuesday, March 13, vehicle and pedestrian access to the Essex Vicinage Court Complex will be limited from Monday, March 12 through Wednesday, March 14. Local street closures are possible. In addition, the availability of the juror and public parking area, accessible via Howard Street, 13th Avenue and South Orange Ave., will be limited.
