NOTICE OF *OBJECTION* TO  
ORDER TO SHOW CAUSE

- A. Given that Plaintiff now intends to properly serve Notice of Intention to Foreclose, I object to the extent that I desire to file responsive pleadings to Plaintiff's Complaint for Foreclosure.


D. I have retained the assistance of counsel for this matter. Based upon these facts, it is respectfully requested that defendant be granted leave to file a responsive pleading.




