

CERTIFICATION OF CHERYL R. MARCHANT

CHERYL R. MARCHANT, being of full age, certifies as follows:

1. I am employed by Aurora Loan Services LLC ("Aurora") as a Vice President – Foreclosure/Bankruptcy. I submit this certification on behalf of Aurora as requested by the court in Supplemental Administrative Order Directing Submission of Information by Residential Mortgage Foreclosure Plaintiffs Concerning Their Document Execution Practices, dated January 31, 2011.

2. Aurora is a limited liability company organized under the laws of the State of Delaware and is a wholly owned subsidiary of Aurora Bank FSB.

3. Aurora is a mortgage loan servicer currently responsible for servicing 6,544

residential mortgage loans in New Jersey.¹ Of the 6,544 mortgage loans Aurora currently services in New Jersey, 2,024 mortgage loans are in some stage of the foreclosure process.

4. Attached as Schedule A is a list of the investors that Aurora is currently servicing residential mortgage loans for in New Jersey. This list includes a tally of the number of such loans for each investor and the number of those loans for each investor that are in some stage of the foreclosure process.

5. Other mortgage loan servicers do not service residential mortgage loans for Aurora in New Jersey.

6. As a mortgage loan servicer, there are no impediments to Aurora's ability to make the demonstration pursuant to the Administrative Order entered by the court on December 20, 2010. Aurora will be able to make such a demonstration as directed by the court.
