INTRODUCTORY STATEMENT

In response to Plaintiffs Reply in the above captioned matter I will answer each Question in turn.

In addition, now that Plaintiff has made statements regarding the Assignment from Federal Home Loan Mortgage Corporation to TruCap Grantor Trust 2010-12, which gives Rushmore Loan Management Services, US Bank and TruCap Grantor Trust 2010-12 standing, and the right to pursue Foreclosure Proceedings against my Home I will Show Plaintiffs Assignment to be Fraudulent, Illegal, and that this Particular Foreclosure Case should be Dismissed until such time when Some Entity can prove ownership of the Note, and Mortgage.

ARGUMENT

Section I. Plaintiffs incorrectly claim Defendants Case is Uncontested.

OBJECTION: Defendant directs the Courts attention to Plaintiffs letter to Defendant of May 16, 2012,(after Judge Suter ruled on February 17, 2012), regarding Summary Judgment in which Plaintiff States, "It is Respectfully Submitted that this matter falls outside the scope of the Supreme Court Directive issued on April 4, 2012. The Supreme Court Directive clearly states that it applies to Uncontested matters in which Final Judgment has not yet been entered. As such this matter falls Outside the Plain language of the Supreme Court Directive". Please see Exhibit B of Defendants original Brief.

To confirm the Fact This case is Contested, The NJ Courts site states, Until an answer is filed, all Uncontested Foreclosures are handled by the Foreclosure unit in Trenton, NJ.. The Foreclosure unit forwards all cases in which Contested answers are filed, with supporting Documents to the Chancery Division.(In my case Burlington County, NJ),.(Please see Exhibit 1.)

Defendant again directs the Courts attention to the Defendants Contested Court Filings in Exhibit C of Defendants original Brief, additional proof Defendant Contested Plaintiffs .Foreclosure Case on multiple occasions.

On these Truths alone Plaintiffs Statements should be Stricken and Plaintiffs Case Rejected.

Section II. of Plaintiffs Reply Brief states that TruCap Grantor Trust 2010-12 is the correct Creditor, This is False and Misleading.

OBJECTION: As Stated on Defendants Exhibit D in Defendants original Brief US Bank National Association, (US Bank), is the Creditor, as Trustee for TruCap Grantor Trust 2010-12. If this statement by Plaintiff is true, Then Who is US Bank, and why are they so prominently listed as Creditor on Important letters from Rushmore. Plaintiff states in section II. of their Reply Brief that the Exhibit D letter, **"IS OF NO CONSEQUENCE WHATSOEVER"**, I do not Understand, sending out letters of No Consequence, is the Court Expected to Believe this statement. Nowhere on Plaintiffs Reply Brief is US Bank Explained, or referred to.

The fact is Plaintiff again Miss States Important Information regarding the Creditor on the Notice of Intent to Foreclose and this fact alone Demands Dismissal of Plaintiffs Request for Corrective NOI.

Section III. The Foreclosure Defendants have been made aware of the status of their mortgage loan.

OBJECTION: Plaintiff would like the Court to Agree with Plaintiffs Wildly Incorrect Numbers regarding Defendants Mortgage Debt. The Truth is there is No Transparency of what the numbers Represent. No Defendant should accept a Mortgage Amount as owing unless that amount is ledgered so the Debt can be understood. Furthermore, the Aggregate amounts Represent Nothing, they are False, and project a \$63,351.91 Dollar Gift to the Creditor among other Calculated Mistakes on the Same Page.

Defendant Requests for the above Sound Reasons Plaintiffs case must be Dismissed.

Section II,(Revisited), Contained in Plaintiffs Reply Brief, Please Find attached hereto (Exhibit C), Is the Recorded Assignment of Mortgage in which TruCap Grantor Trust2010-12, is the designated Assignee of the Foreclosure Defendants Mortgage, and that the Court in Foreclosure Litigation accepted and acknowledged this Assignment of Mortgage when it entered the October 18, 2011 Order permitting TruCap Grantor Trust 2010-12 to be Substituted in as the Plaintiff in this Foreclosure Litigation.

Objection, Said Mortgage Assignment Provided by Plaintiff to the Court Appears to be Forged, or is the product of a ROBO SIGNER, and is therefore Defective, Illegal and Void.

A ROBO Signer is a person who Signs Hundreds or Thousands of Foreclosure Documents in a Month Swearing that he or she has Personally Reviewed the Mortgage Documents, but has Not Actually Done so. These Foreclosure documents and Affidavits which were Executed by ROBO Signers, and often Employees were then used to establish a Banks Ownership in a Mortgage. Employees from such Financial Giants like Bank of America, J P Morgan Chase, Wells Fargo, GMAC and Deutsche Bank have all stated they have Signed Thousands of Affidavits each month spending only about 30 Seconds on each Affidavit,(the book on foreclosure ,April 28, 2012), ROBO Signers were representing they had personnel knowledge of information which they knew absolutely Nothing about. If the Documents were not signed with Requisite Knowledge then the Mortgage Assignments and other related Documents are Perjured,(Before it's News, ROBO Signers list November 11,2011), ROBO Signers allegedly were given permission By Banks, MERS, and Title Clearing Houses to sign thousands of Mortgage Foreclosure Documents, often using Fictitious Executive Titles, which is Fraudulent.,(Litigation Quarterly, Spring 2011, May 18, by Brett Goldblatt),.

The name Wendy W Hart – Asst. Treasurer,(Corporate Officer), is the Authorizing signatory for Federal Home Loan Mortgage Corporation,(Hereafter FHLMC), who was the Holder of this Mortgage Until Assigned to TruCap on September 15, 2011. Further Discovery revealed the following:

- 1. Wendy W Hart – Assistant Treasurer,(Corporate Officer), works for FHLMC. Wende W Hart- Document Execution, Transfers of Document Custody, (A Clerks Position), works for FHLMC (see Exhibit 2).**

Both Names appear to be the same person.

Upon Closer Examination the Possibility of many Forgeries and False statements of Both Wende and Wendy are apparent. The names are sometimes Signed as Wendy W Hart, or Wende W Hart, Identical Signatures by the same person, Exhibit 3a begins with Plaintiffs Original TruCap Assignment Dated September 15, 2011.,(See Exhibit 3a:1-4, 3b:1-10), Note in Exhibit 3a:1-4, All the Wendy W Hart signatures for these four Documents are the same style or Identical, Then Note Exhibit 3b:1-10, All the Signatures in these Ten Documents are also the same style or Identical, only the Wendy has been changed to Wende.

Now Please Note Document 3a:2, in the upper right corner the name Wende has the letter e crossed off and the letter y is written over the e to make the name of the Fictitious person signing this Document Wendy W Hart instead of Wende W Hart Classifying this Document as Fraudulent! Note Document 3b:10, the upper right corner signature is completely different than the lower left corner signature for the Same Person, Wende W Hart, These Documents, Including the FHLMC-TruCap Assignment Appear to be ROBO Signed, and Fraudulent.

Defendant has shown many different styles of Wendy, Wende signatures, Exactly like the Notorious ROBO Signers. The signatures of Wendy, Wende W Hart appears to vary from one group of ROBO Signed Foreclosure Document or Affidavit Document to another, with each group of signatures ROBO Signed by the same person with an Exact identical Style of Signature. (see Exhibits 4a:1-4, 4b:1-5, 4c:1-4, 4d:1-2, and 4e:1-2), Again, more Fraud!

Plaintiff's Mortgage Assignment by Federal Home Loan Mortgage Corporation to TruCap Grantor Trust 2010-12, Giving TruCap Standing as the Owner of this Mortgage and the Right to Foreclose on my Home is Completely Fraudulent. The Contents of the Assignment were not Validated as to their Authenticity by the Plaintiff. There could Not have been Any Personnel Knowledge of the Plaintiffs FHLMC - TruCap Assignment by whoever the signer of Wendy W Harts name was as has been shown by Defendant, Considering the other ROBO Signed Wende, Wendy W Hart Documents. More Fraudulent Acts.

The Title of Assistant Treasurer was used extensively by Wendy and Wende W Hart, though in the FHLMC Document, Exhibit 2, Wende W Hart is listed as having the title of Document Execution, AND OR Transfer of Document Custody, or a clerk position, Not a Corporate Officer Position as Assistant Treasurer, Again Exactly mirroring Illegal ROBO Signer Activity!

These Fraudulent Foreclosure Documents and Affidavits span over twenty years!

On January 10, 2013 I contacted FHLMC to speak with Wendy W Hart, Assistant Treasurer, Operator #3 one Marylyn, (She would not give her last name), stated that Wendy W Hart was working there. When I asked what Wendy's title was I was told, Funding and Securities, I said not Assistant Treasurer, and Marylyn said, "No, Funding and Securities is her, meaning Wendy's title. I asked if any other Wendy or Wende W Harts were employed by FHLMC, Now known as Freddie Mac, and Marylyn said No.

To further outline the Fraudulent Activity of Well Known ROBO Signers and the use of multiple ROBO Signers to accomplish said monthly signing Quotas I have included the following Exhibits in Support of my Reply Brief.

The Chancery Division/General Equity hears cases that seek what is known as equitable relief rather than monetary compensation. Equitable relief usually involves the court compelling or restricting actions of one of the parties (such as labor injunctions, foreclosures, dissolution of a corporation or partnership, execution of wills and distribution of estates)

Example of Chancery Division Case Types Include:

Injunctive Relief: Temporary Restraining Order.

Strikes: Temporary Restraining Order.

Picketing: Temporary Restraining Order.

Quiet Title: Remove names on title search.

Accounting: To establish assets/liabilities of business or trust funds.

Cancel Mortgage: Paid mortgage not recorded and business firm cannot be located.

Partition: Two or more persons own real estate and cannot agree on terms of usage

Restrictive Covenant: To stop former employee from competing against employer when an agreement was signed not to compete

Specific Performance: Compels enforcement of contract.

Dissolution: Splitting of partnership.

Foreclosures

Until an Answer is filed, all uncontested foreclosures are handled by the Foreclosure Unit in Trenton, NJ. The Foreclosure Unit forwards all cases in which contested Answers are filed (and all subsequent papers involving the contested foreclosure) to the Chancery Division.
