Harz, J.S.C. pursuant to the Supreme Court's Order of July 22, 2016 and January 24, 2013 Order designating this matter for Multicounty Litigation Status ("MCL") of Stryker Rejuvenate & ABG II Modular Hip Implant Litigation (hereinafter referred to as "Stryker") [a Multidistrict Litigation ("MDL") pending before the Honorable Donovan W. Frank, USDJ], and having come before the Court on the Motion of defendant Howmedica Osteonics Corp. ("HOC") for an order dismissing Plaintiffs' Complaints with prejudice in furtherance of the private Settlement Agreement under which these plaintiffs' claims have been resolved, and the parties, having stipulated to the dismissal of these plaintiffs' claims with prejudice, the following order is hereby entered:

ORDERED

1. The lawsuits of the plaintiffs identified on Schedule A attached hereto shall be dismissed in their entirety with prejudice.

2. The claims of the plaintiffs identified on Schedule B attached hereto shall be partially dismissed with prejudice, leaving active all claims relating to the hip that was not resolved through the private global settlement program.
