IT IS FURTHER ORDERED that:

2. Mr. Asfendis shall, and hereby does, consent to the appointment of the Clerk of the Supreme Court as agent upon whom service may be made for all actions against him or his firm that may arise out of his participation in this matter;

3. Mr. Asfendis shall immediately notify the Court of any matter affecting his standing at the Bar of any other court;

4. Mr. Asfendis shall have all pleadings, briefs and other papers filed with this Court signed by an attorney of record authorized to practice in New Jersey, who shall be held responsible for them, the conduct of the case and the attorney admitted herein;

5. No adjournment or delay in discovery, motions, and trial or any other proceeding shall occur or be requested by reason of the inability of Mr. Asfendis to be in attendance;

6. Mr. Asfendis will not be designated as trial counsel for purposes of Rule 4:25-4;

7. Mr. Asfendis must, within ten (10) days of receipt of this Order, pay the fees required by R. 1:20-1 and R. 1:28-2;

8. Automatic termination of *pro hac vice* admission shall occur for failure to make the required annual payments as set forth in Paragraph 7 herein. Proof of such payments, after filing proof of the initial payment, shall be made no later than February of each year;

9. Non-compliance with any terms of these requirements shall constitute grounds for removal; and

IT IS FURTHER ORDERED that Counsel for HOC shall serve a copy of this Order on all parties with seven (7) days.
