IT IS on this 12th day of Oct, 2007

ORDERED that:

A. Kamie Kendall v. Hoffmann-La Roche Inc.

Discovery in the matter of Kamie Kendall v. Hoffmann-La Roche Inc. Docket No. ATL-L-8213-05 shall proceed in anticipation of a January 2008 trial date.

B. Clinical Trials

Pursuant to CMO 12, Defendants provided Plaintiffs a list derived from the RDR database of all Roche studies that have been done on Isotretinoin. By October 30, 2007, Defendants shall submit a certification describing how Defendants would ascertain which studies on the list were or were not submitted to the FDA. The certification shall estimate the costs and manpower efforts to complete this task.

D. Updates and Authorizations in Trial Set Cases

In cases that have trial settings, Defendants may request authorizations as needed and the "once a month" restriction set forth in CMO 8 does not apply. Plaintiffs shall use best efforts to return the executed authorizations within two weeks of receipt.


Every thirty days, beginning October 5, 2007, Plaintiffs Kamie Kendall and Todd Wagner will each 1) provide Defendants the complete names and addresses of any and all health care providers that they have seen and pharmacies they have visited in the preceding thirty days, 2) identify any changes in insurance and provide the complete names and address of any new insurance policies, as well as the name of the policyholder and the policy numbers, and 3) identify any changes of employment, and provide the complete names and addresses of any new employers.

F. Next Case Management Conference
