
1. abide by the Rules of Court for the State of New Jersey, including all disciplinary rules;

**ORDERED** that Richard L. Nahigian shall make payment of fees as provided in the New Jersey Rules of Court, Rule 1:28-1(b), 1:28-2 and 1:28B-1(e), within thirty (30) days of the date of this Order; and it is further
