Nagel of Nagel Rice & Mazie, LLP, upon notice to all interested parties, have moved before this Court for admission pro hac vice of Frederick T. Kuykendall, III, Esq., the court having considered the papers submitted in support thereof; and the Court having found that Frederick T. Kuykendall, III, Esq. is a member in good standing before the bar of the highest court of the state where he is domiciled and principally practices law; and for other good cause show.

IT IS on this 17 day of Aug 2006, hereby

ORDERED that the motion is granted, and Frederick T. Kuykendall, III, Esq. is admitted to practice pro hac vice before this Court, pursuant to R. 1:21-2; for all purposes and in all proceedings connected with the above case in the same manner as an attorney who is admitted to

practice in this State and is domiciled and maintains an office for the practice of law in the State of New Jersey, provided that each shall:

1. abide by the Rules of the Court for the State of New Jersey, including all disciplinary rules;
2. consent to the appointment of the Clerk of the Supreme Court as an agent upon whom service of process maybe made for all actions against him or his firm that may arise out of his participation in this matter;
3. notify the Court immediately of any matter affecting his standing at the bar of any Court; and
4. have all pleadings, briefs and other papers filed in this Court signed by an attorney-at-law of this Court employed by the law firm of Nagel, Rice & Mazie, LLP, who shall be responsible for them, for the conduct of the cause of Frederick T. Kuykendall, III, Esq., it is further

ORDERED that Frederick T. Kuykendall, III, Esq., shall make payment of fees as provided in the New Jersey Rules of Court, R. 1:20-1(b). 1:28-2 and 1:28B-1(e) within 30 days of the date of this Order and it is further

ORDERED that the Clerk of this Court shall forward a copy of this Order to the Treasurer of the New Jersey Fund for Client Protection, and it is further

ORDERED that a copy of this Order shall be served by attorneys for plaintiffs upon defendants within seven (7) days of their receipt thereof.
