3. notify the Court immediately of any matter affecting his standing before this Court; and
4. have all pleadings and other papers filed in this Court signed by an attorney-at-law of this Court employed by the firm of Seeger Weiss LLP, who shall be responsible for the conduct of Charles E. Schaffer, Esq., and it is further

ORDERED that Charles E. Schaffer, Esq., shall make payment of fees as provided in the New Jersey Rules of Court, R. 1:28-1(b), 1:28-2 and 1:28b-1(e), within thirty (30) days of the date of this order, and it is further
