AND NOW, Brian P. Sharkey, counsel for defendants, Barr Pharmaceuticals, LLC (f/k/a Barr Pharmaceuticals, Inc.), and Barr Laboratories, Inc., in the above-captioned action, upon notice to all interested parties, has moved before this Court for the admission *pro hac vice* of Jennifer Snyder Heis; the Court having considered the papers in support thereof; and the Court having found that Jennifer Snyder Heis is a member in good standing of the bar of the highest court in the state where she is domiciled and principally practices law, and further good cause shown,

IT IS ON THIS 13 day of April, 2009,

ORDERED that the Motion is granted and Jennifer Snyder Heis, of the law firm of ULMER & BERNE LLP, is admitted to practice *pro hac vice* before this Court pursuant to R. 1:21-2, for all purposes and in all proceedings in connection with this action in this

Court in the same manner as an attorney who is admitted to practice in this state, and is domiciled and maintains an office for the practice of law in the State of New Jersey, provided that she shall:

1. abide by the Rules of Court for the State of New Jersey, including all disciplinary rules;
2. consent to the appointment of the Clerk of the Supreme Court as an agent upon whom service of process may be made for all actions against her and her firm that may arise out of her participation in this matter;
3. notify the Court immediately of any matter affecting her standing before this Court; and
4. have all pleadings and other papers filed in this Court signed by an attorney-at-law of this Court employed by the firm of PORZIO, BROMBERG & NEWMAN, P.C., who shall be responsible for the conduct of Jennifer Snyder Heis, and it is further

ORDERED that Jennifer Snyder Heis shall make payment of fees as provided in the New Jersey Rules of Court, R. 1:28-1(b), 1:28-2, and 1:28b-1(e); and it is further

ORDERED that the Clerk of this Court shall forward a copy of this Order to the Treasurer of the New Jersey Fund for Client Protection; and it is further

ORDERED that copies of this Order shall be served by attorneys for defendants, Barr Pharmaceuticals, LLC (f/k/a Barr Pharmaceuticals, Inc.), and Barr Laboratories, Inc., upon counsel for plaintiff within seven (7) days of receipt hereof.
