**ORDERED** that Matthew J. Griffin shall make payment of fees as provided in the New Jersey Rules of Court, R. 1:28-1(b), 1:28-2 and 1:28B-1(e), within thirty (30) days of the date of this Order; and it is further

**ORDERED** that the Clerk of this Court shall forward a copy of this Order to the Treasurer of the New Jersey Fund for Client Protection; and it is further

**ORDERED** that copies of this Order shall be served by attorneys for Roche upon all counsel of record within seven (7) days of the receipt thereof.
