2. Consent to the appointment of the Clerk of the Supreme Court as an agent upon whom service of process may be made for all actions his and his firm that may arise


out of his participation in this matter;

**ORDERED** that Jeff D. Crawford shall make payment of fees as provided in the New Jersey Rules of Court, Rule 1:28-1(b), 1:28-2 and 1:28B-1(e), within thirty (30) days of the date of this Order, and it is further

**ORDERED** that the Clerk of this Court shall forward a copy of this Order to the Treasurer of the New Jersey Fund for Client Protection; and it is further
