AND NOW, Brian P. 4. have all pleadings and other papers filed in this Court signed by an attorney-at-law of this Court employed by the firm of PORZIO, BROMBERG & NEWMAN, P.C., who shall be responsible for the conduct of Kimberly L. Beck, and it is further

ORDERED that Kimberly L. Beck shall make payment of fees as provided in the New Jersey Rules of Court, R. 1:28-1(b), 1:28-2, and 1:28b-1(e); and it is further

ORDERED that the Clerk of this Court shall forward a copy of this Order to the Treasurer of the New Jersey Fund for Client Protection; and it is further

ORDERED that copies of this Order shall be served by attorneys for defendants, Barr Pharmaceuticals, LLC (f/k/a Barr Pharmaceuticals, Inc.), and Barr Laboratories, Inc., upon counsel for plaintiffs within seven (7) days of receipt hereof.
