**THIS MATTER**, having been brought to the Court by Segal McCambridge Singer & Mahoney, Ltd., attorneys for Defendants, Mylan Bertek Pharmaceuticals, Inc., f/k/a Bertek Pharmaceuticals, Inc., Mylan Pharmaceuticals, Inc. and Mylan, Inc. f/k/a Mylan Laboratories, Inc. (collectively "Mylan Defendants") and Cardinal Health 409, Inc., f/k/a R.P. Scherer, n/k/a Catalent Pharma Solutions, Inc. ("Cardinal Health"), for an Order pursuant to R. 1:21-2 **GRANTING *pro hac vice*** admission of Jason M. Reefer, Esquire, and the Court having considered the moving and responding papers and the attached Certifications;


IT IS, on the 21 day of December, 2010, **ORDERED** that Jason M. Reefer, Esquire, is hereby admitted ***pro hac vice*** in all proceedings in connection with the actions listed on Schedule A, subject to the following requirements

Jason M. Reefer is required to:

1. Abide by the rules of governing the Courts of the State of New Jersey, including all disciplinary rules;
2. Appoint the Clerk of the Supreme Court as agent upon whom service of process may be made for all actions against the attorneys of the attorneys' firm that may arise out of the attorney's participation in this matter.
3. Notify the Court immediately of any matter affecting the attorney's standing at the Bar of any other court;
4. Have all pleadings, briefs, and other papers filed with the Court signed by the attorney of record authorized to practice in this State, who shall be held responsible for them and for the conduct of the cause and of the admitted attorney therein;
5. Jason M. Reefer, Esquire cannot be designated as trial counsel;
6. No delay in discovery motions, trial or any other proceedings shall occur or be requested by reason of the inability of these attorneys to be in attendance;
7. Within ten (10) days, pay the fees required by R. 1:20-1(b) and R. 1:28-2 and submit an Affidavit of Compliance to the Ethics Financial Committee and the New Jersey Lawyers Fund for client protection, and these payments shall be made any year in which Jason M. Reefer, Esq. continues to represent the Mylan Defendants and Cardinal Health in any matter pending in this Court;
8. Automatic termination of *pro hac vice* admission will occur for failure to make the required annual payment to the Ethics Financial Committee and the New Jersey Lawyers Fund for Client Protection. Proof of such payment, after filing proof of the initial payment, shall be made no later than February of each year; and

9. Noncompliance with any of these requirements shall constitute grounds for removal.

**IT IS FURTHER ORDERED** that counsel shall serve a conformed copy of this Order upon all counsel of record within five (5) days of the date hereof.
