ORDERED, that Jaime M. Farrell, Esq., shall have all pleadings, briefs and other papers filed with the Court signed by an attorney of record authorized to practice in this State, who shall be held


responsible for them and for the conduct and cause of Jaime M. Farrell, Esq.; and it is further
