
Court in the same manner as an attorney who is admitted to practice in this state, and is domiciled and maintains an office for the practice of law in the State of New Jersey, provided that he shall:

4. have all pleadings and other papers filed in this Court signed by an attorney-at-law of this Court employed by the firm of PORZIO, BROMBERG & NEWMAN, P.C., who shall be responsible for the conduct of Michael J. Suffern, and it is further
