

3. Notify the Court immediately of any matter affecting his standing before this Court; and
4. Have all pleadings and other papers filed in the Court signed by an attorney-at-law of this Court employed by the firm of Williams Cuker Berezofsky, LLC, who shall be responsible for the conduct of J. Van Robichaux, Jr.; and it is further
