1. Abide by the Rules of Court for the State of New Jersey, including all


disciplinary rules;

3. Notify the Court immediately of any matter affecting his standing before this Court; and
4. Have all pleadings and other papers filed in the Court signed by Roger W. Orlando of The Orlando Firm, P.C., who shall be responsible for the conduct of Mark Ekonen, Esq.; and it is further

ORDERED that Mark Ekonen, Esq. shall make payment of fees as provided in the New Jersey Rules of Court, Rule 1:28-1(b), 1:28B-1(e), within thirty (30) days of the date of this Order; and it is further

ORDERED that the Clerk of this Court shall forward a copy of this Order to the Treasurer of the New Jersey Fund for Client Protection; and it is further
