IT IS ON THIS 13 day of NOV., 2013

ORDERED that the Motion is granted and Christopher McRae is admitted to practice *pro hac vice* before this Court pursuant to R. 1:21-2 for all purposes and in all proceedings in connection with the actions listed on Schedule A, provided that Christopher McRae shall:


1. abide by the Rules of Court for the State of New Jersey, including all disciplinary rules;
2. consent to the appointment of the Clerk of the Supreme Court as an agent upon whom service of process may be made for all actions against him and his firm that may arise out of his participation in this matter;

3. notify the Court immediately of any matter affecting his standing before this Court; and
4. have all pleadings and other papers filed in the Court signed by an attorney-at-law of this Court employed by the firm of Gibbons P.C., who shall be responsible for the conduct of Christopher McRae; and it is further

ORDERED that Christopher McRae shall make payment of fees as provided in the New Jersey Rules of Court, R. 1:28-1(b), 1:28-2 and 1:28B-1(e), within thirty (30) days of the date of this Order; and it is further

ORDERED that the Clerk of this Court shall forward a copy of this Order to the Treasurer of the New Jersey Fund for Client Protection; and it is further

ORDERED that copies of this Order shall be served by attorneys for Roche upon all counsel of record within seven (7) days of the receipt thereof.
