
manner as an attorney who is admitted to practice in this State and is domiciled and maintains an office for the practice of law in the State of New Jersey, provided that she shall:

3. notify the Court immediately of any matter affecting her standing before this Court; and
4. have all pleadings and other papers filed in this Court signed by an attorney-at-law of this Court employed by the firm of Seeger Weiss LLP, who shall be responsible for the conduct of Morgan A. Gottlieb, Esq., and it is further

ORDERED that Linda A. Alley, Esq., shall make payment of fees as provided in the New Jersey Rules of Court, R. 1:28-1(b), 1:28-2 and 1:28b-1(e), within thirty (30) days of the date of this order, and it is further
