Automatic termination of *pro hac vice* admission shall occur for the failure to make the required annual payment of the Annual Fee and the annual payment to the Lawyer's Assistance Fund and the New Jersey Lawyer's Fund for Client Protection. Proof of such payment, after filing proof of the initial payment, shall be made no later than February each year;

8. Noncompliance with any of these requirements shall constitute grounds for removal;

9. A copy of this Order shall be served on all parties within seven (7) days.
