
as an attorney who is admitted to practice in this State and is domiciled and maintains an office for the practice of law in the State of New Jersey, provided that she shall:

3. Notify the Court immediately of any matter affecting her standing before this Court; and
4. Have all pleadings and other papers filed in the Court signed by an attorney-at-law of this Court employed by the firm of Balkin & Eisbrouch, who shall be responsible for the conduct of Donna G. Zamanian, Esq.; and it is further
