Defense counsel shall notify plaintiff's counsel within thirty (30) days of the date of this Order if their client was incorrectly named in the Complaint. Counsel may be barred from raising this defense at a later time for failure to comply.

PLEADINGS

The complaint is hereby amended to reflect the wrongful death claim on behalf of plaintiff Harvey Birch and to name Salvatrice Birch as executrix of the estate. Any defendants having previously filed an answer to the complaint are hereby deemed to have filed an amended answer to the complaint without any further filing.

June 10, 2015

The time by which plaintiff may serve summons and complaint upon defendant(s) is extended to this date.

DISCOVERY

Plaintiff shall serve subpoena upon counsel for AT&T Services, who has been authorized to accept service, for release of any employment related records. Plaintiff shall serve upon counsel for Alcatel Lucent executed authorization, to allow the release of Western Electric employment records. These records shall be served within thirty (30) days from receipt of subpoena and/or authorizations.

- June 10, 2015 Plaintiff shall serve answers to wrongful death interrogatories (and serve wrongful death reports) by this date.
- September 8, 2015 Initial discovery deadline; may be extended at the next Case Management Conference. Plaintiff shall identify fact witnesses within this time.
- November 9, 2015 Defendants shall serve answers to standard interrogatories by this date.
