THIS MATTER having been opened to the Court by Plaintiff, Sandra Maccaferri, through counsel, and with the consent of Defendants, DePuy Orthopaedics, Inc., DePuy, Inc., DePuy International Ltd., Johnson & Johnson, Johnson & Johnson Services, Inc., and Johnson & Johnson International, through counsel, for an Order reinstating this matter,

WHEREAS this matter was originally filed in the Superior Court of New Jersey, Bergen County, Law Division, and was centralized for case management purposes in *In re DePuy ASR Hip Implants Litigation*, Case No. 293;

WHEREAS Plaintiff, Sandra Maccaferri, alleges that she was implanted with DePuy ASR Hip Implants in both her left and right hip;

WHEREAS, pursuant to the terms of a November 19, 2013 Settlement Agreement, Plaintiff enrolled and agreed to settle all claims related to Sandra Maccaferri's LEFT HIP ONLY;



WHEREAS, by Order dated August 7, 2014, the Court dismissed all claims in *In re DePuy ASR Hip Implants Litigation* that are in the process of being resolved, including the claims of Plaintiff Sandra Maccaferri;

WHEREAS, Plaintiff continues to pursue a cause of action related to Sandra Maccaferri's RIGHT HIP;

WHEREAS, by Order dated October 15, 2014, the court reinstated Plaintiff's claims *In re DePuy ASR Hip Implants Litigation* with regard to Plaintiff's right hip;

WHEREAS, Pursuant to Case Management Order #31 dated November 19, 2014, Plaintiff agreed to dismiss her unrevised right hip claims;


WHEREAS, by order dated July 1, 2015, the court dismissed Plaintiff's claims *In re DePuy ASR Hip Implants Litigation* with regard to Plaintiff's right hip;

WHEREAS, Pursuant to Case Management Order #31 dated November 19, 2014, Plaintiff wishes to reinstate her claims as Plaintiff's right hip has now been revised;

And for good cause shown, the following Order is hereby entered:

**ORDERED** that the claims of Plaintiff Sandra Maccaferri shall be reinstated to an active docket status as to the claims related to the right hip only.
