
**ORDER TO ADMIT  
BRUCE HURLEY, ESQ.  
PRO HAC VICE**

**THIS MATTER** being opened to the Court by Michael C. Zogby, Esq., a New Jersey attorney and one of the attorneys of record for defendants DePuy Orthopaedics, Inc., DePuy, Inc., Johnson & Johnson, Johnson & Johnson Services, Inc., and Johnson & Johnson International, for an Order admitting Bruce Hurley, Esq. *pro hac vice*, and the Court having considered the respective certifications of Michael C. Zogby, Esq. and Bruce Hurley, Esq., submitted in support of the motion, and for good cause having been shown:

IT IS this 27<sup>th</sup> day of June, 2017 **ORDERED** that Bruce Hurley, Esq. shall be and hereby is admitted *pro hac vice* for defendants DePuy Orthopaedics, Inc., DePuy, Inc., Johnson & Johnson, Johnson & Johnson Services, Inc., and Johnson & Johnson International, in all phases of the trial, subject to the following conditions:

1. Bruce Hurley, Esq. shall abide by the New Jersey Court Rules including all disciplinary rules, R. 1:20-1 and R. 1:28-2.
2. Bruce Hurley, Esq. shall, and hereby does, consent to the appointment of the Clerk of the Supreme Court as agent upon whom service of process may be made for all actions against him or King & Spalding LLP that may arise out of his participation in this matter.
3. Bruce Hurley, Esq. shall immediately notify the Court of any matter affecting his standing at the Bar of any other jurisdiction.
4. Bruce Hurley, Esq. shall have all pleadings, briefs and other papers filed with the court signed by an attorney of record authorized to practice in New Jersey, who shall be held responsible for them, the conduct of the litigation and the attorney admitted herein.
5. Bruce Hurley, Esq. cannot be designated as trial counsel.
6. No discovery, motion, trial or any other proceeding delay shall occur or be requested by reason of the inability of Bruce Hurley, Esq. to be in attendance.
7. Bruce Hurley, Esq. must, within ten (10) days of receipt of this Order, pay the fees required by R. 1:20-1(b) and R. 1:28-2 and submit an affidavit of compliance.
8. The *pro hac vice* admission of Bruce Hurley, Esq. will automatically terminate for failure to make the initial and any annual payment required by R. 1:20-1(b) and R. 1:28-2.
9. Non-compliance with any of the terms of this Order shall constitute grounds for removal.
10. A true copy of this Order shall be served upon all counsel of record within seven (7) days of the date hereof.
