4. Michael R. Conner, Esq. shall have all pleadings, briefs and other papers filed with the court signed by an attorney of record authorized to practice in New Jersey, who shall be held responsible for them, the conduct of the litigation and the attorney admitted herein.

5. Michael R. Conner, Esq. cannot be designated as trial counsel.


6. No discovery, motion, trial or any other proceeding delay shall occur or be requested by reason of the inability of Michael R. Conner, Esq. to be in attendance.

9. Non-compliance with any of the terms of this Order shall constitute grounds for removal.

10. A true copy of this Order shall be served upon all counsel of record within seven (7) days of the date hereof.
