

IT IS HEREBY STIPULATED AND AGREED by and between Plaintiff in the above-captioned case, Eunice Bentley, and the above-named Defendant, Merck Sharp & Dohme Corp. (formerly known as Merck & Co., Inc.) ("Merck"), through their respective undersigned counsel, that each and every claim in Plaintiff's Complaint regarding allegations of osteonecrosis of the jaw and each and every claim of Plaintiff relating to jaw or dental injuries, against Defendant Merck are hereby dismissed with prejudice. Each party is to bear its own costs and attorneys' fees.

Plaintiff's jaw related claims against Defendant Teva Pharmaceuticals USA Inc. is not dismissed by this Stipulation of Dismissal and remains pending. All remaining claims related to femur fractures remain pending.


