IT IS HEREBY STIPULATED AND AGREED by and between Plaintiff in the above-captioned case, Sharon Lea Wyatt, and the above-named Defendant, Merck Sharp & Dohme Corp. (formerly known as Merck & Co. Inc.) (“Merck”), through their respective undersigned counsel, that all of Plaintiff’s claims against Merck are hereby dismissed with prejudice. Each party is to bear its own costs and attorneys’ fees.

Plaintiff’s claims against Defendants Watson Pharmaceuticals, Inc., Watson Laboratories, Inc., Mylan Inc. f/k/a Mylan Laboratories, Mylan Pharmaceuticals Inc., and Sun Pharmaceutical Industries¹ are not dismissed by this Stipulation of Dismissal and remain pending.

¹ Sun Pharmaceutical Industries, Inc., was originally named as a party to this action, but it merged with Caraco Pharmaceutical Laboratories, Ltd. on February 28, 2013, and Caraco Pharmaceutical Laboratories, Ltd. was the surviving entity. On July 1, 2014 Caraco Pharmaceutical Laboratories, Ltd. changed its name to Sun Pharmaceutical Industries, Inc.


