WHEREAS, Plaintiff, by and through its attorneys The Levensten Law Firm, P.C., upon notice to all interested parties, has moved before this Court for admission *pro hac vice* of THOMAS ALEXANDER TAYLOR, ESQ., the Court having considered the papers submitted in support thereof; and the Court having found that THOMAS ALEXANDER TAYLOR, ESQ., is a member of good standing before the bar of the highest court of the state where he is domiciled and principally practices law, and for other good cause shown.

proceedings in the same manner as an attorney who is admitted to practice in this State and is domiciled and maintains an office for the practice of law in the State of New Jersey, provided that:

1. THOMAS ALEXANDER TAYLOR, ESQ. shall abide by the *New Jersey Court Rules* including all disciplinary rules, *R. 1:20-1* and *R. 1:28-2*;

2. THOMAS ALEXANDER TAYLOR, ESQ. shall, and hereby does, consent to the appointment of the Clerk of the Supreme Court as his agent upon whom service of process may be made for all actions against Scott Levensten that may arise out of his participation in these cases

3. THOMAS ALEXANDER TAYLOR, ESQ. shall notify the Court immediately of any matter affecting his standing at the bar of any court; and

4. THOMAS ALEXANDER TAYLOR, ESQ. shall have all pleadings, briefs and other papers filed with the court signed by an attorney of record authorized to practice law in the State of New Jersey, who shall be held responsible for the cases and for the conduct of Scott Levensten therein.

ORDERED that THOMAS ALEXANDER TAYLOR, ESQ. must, within thirty (30) days, submit a copy of this Order and pay the fees required by *R. 1:20-1(b)*, *R. 1:28-2* and *1:28B-1(e)*, and it is further

ORDERED that a copy of this Order shall be served on all parties within seven (7) days of the date hereof.
