IT IS on this 16th day of December, 2008, hereby


ORDERED that the motion is granted, and Theodore V. H. Mayer, Esq. is admitted to practice pro hac vice before this Court, pursuant to R. 1:21-2, for all purposes and in all proceedings connected with the instant action in the same manner as an attorney who is admitted to practice in this State and is domiciled and maintains an office for the practice of law in the State of New Jersey, provided that he shall:

1. abide by the Rules of the Court for the State of New Jersey, including all disciplinary rules;
2. consent to the appointment of the Clerk of the Supreme Court as an agent upon whom service of process may be made for all actions against his firm that may arise out of his participation in this matter; and
3. notify the Court immediately of any matter affecting his standing at the bar of any Court; and
4. have all pleadings, briefs and other papers filed in this Court signed by an attorney-at-law of this Court employed by the law firm of Hughes Hubbard & Reed LLP, who shall be responsible for the conduct of the cause and of Theodore V. H. Mayer, Esq.; and it is further

ORDERED that Theodore V. H. Mayer, Esq. shall make payment of fees as provided in the New Jersey Rules of Court, R. 1:20-1(b), 1:28-2 and 1:28B-1(e); and it is further

ORDERED that the Clerk of this Court shall forward a copy of this Order to the Treasurer of the New Jersey Fund for Client Protection; and it is further

ORDERED that a copy of this Order shall be served by attorneys for defendant Merck upon attorneys for plaintiffs within seven (7) days of their receipt thereof.
