PRO HAC VICE**

This matter having been opened to the Court upon the motion of plaintiffs, by and through their attorneys PARKER WAICHMAN LLP, for an Order permitting Raymond C. Silverman, Esq., to appear in the above-captioned litigation *pro hac vice*, upon due notice to all parties; and the Court having considered the papers submitted; and for good cause shown,

IT IS on this 30<sup>th</sup> day of September, 2013,

**ORDERED** that Raymond C. Silverman, Esq. is hereby admitted *pro hac vice* in the matter of *Robin Caravello and Thomas Caravello v. Merck Sharp & Dohme Corp. f/k/a Merck & Co., Inc.*, and is authorized to appear and participate with other counsel for Plaintiffs pursuant to R. 1:21-2; and it is further

**ORDERED** that Mr. Silverman is authorized to appear *pro hac vice* subject to the following conditions:

(1) Mr. Silverman shall abide by the Rules Governing the Courts of the State of New Jersey, including all Disciplinary Rules, R. 1:20-1 and R. 1:28-2;

(2) Mr. Silverman, and hereby does, consent to the appointment of the Clerk of the Supreme Court as his agent upon whom service of process may be made for all actions against him or his firm that may arise out of his participation in this matter;

(3) Mr. Silverman shall immediately notify the Court of any matter affecting his standing at the Bar of any other jurisdiction;

(4) Mr. Silverman shall have all pleadings, briefs and other papers filed with this Court signed by an attorney of record authorized to practice in New Jersey, who shall be held responsible for them, the conduct of the litigation, and Mr. Silverman, the attorney admitted herein;

(5) Mr. Silverman cannot be designated as trial counsel;

(6) No discovery, motion, trial or any other proceeding delay shall occur or be requested by reason of the inability of Mr. Silverman to be in attendance;

(7) Mr. Silverman must, within ten (10) days, pay the fees required by R. 1:20-1(b) and R. 1:28-2 and submit an affidavit of compliance;


(8) *Pro hac vice* admission will automatically terminate for failure to make the initial and any annual payment required by R. 1:20-1(b) and R. 1:28-2;

(9) Clerk of the Court shall forward a copy of this order to the New Jersey Lawyer's Fund for Client Protection;

(10) Non-compliance with any of the terms of this order shall constitute grounds for removal; and it is further

**ORDERED** that a copy of this Order shall be served upon all parties within seven (7) days from the date hereof.
