
**ORDER ADMITTING
RANDALL L. CHRISTIAN, ESQ.
PRO HAC VICE**

This matter being opened to the Court by Charles F. Rysavy, Esq., a New Jersey attorney and the attorney of record for Genentech, Inc., GlaxoSmithKline LLC, Hoffmann-La Roche Inc. and Roche Laboratories Inc. ("Defendants"), to permit Randall L. Christian, Esq., an attorney admitted to the practice of law in the State of Texas, to participate with other counsel for Defendants in all phases of trial, and it appearing that Randall L. Christian, Esq. is a licensed attorney in good standing in the State of Texas, and it appearing that Randall L. Christian, Esq. is not an attorney admitted to the practice of law in the State of New Jersey,

It is on this ¹⁸ day of April, 2013, ORDERED that Randall L. Christian, Esq. be and hereby is admitted *pro hac vice* and is authorized to appear and participate with other counsel for Defendants in all phases of trial in this matter, subject to the following conditions:

1. Randall L. Christian, Esq. shall abide by the *New Jersey Court Rules*, including all disciplinary rules, *R. 1:20-1* and *R. 1:28-2*.
2. Randall L. Christian, Esq. shall, and hereby does, consent to the appointment of the Clerk of the Supreme Court as his agent upon whom service of process may be made for all actions against Randall L. Christian, Esq. that may arise out of his participation in this matter
3. Randall L. Christian, Esq. shall immediately notify the court of any matter affecting his standing at the Bar of any other jurisdiction.
4. Randall L. Christian, Esq. shall have all pleadings, briefs and other papers filed with the court signed by an attorney of record authorized to practice in New Jersey, who shall be held responsible for them, the conduct of the litigation and the attorney admitted herein.
5. Randall L. Christian, Esq. cannot be designated as trial counsel.
6. No discovery, motion, trial or any other proceeding delay shall occur or be requested by reason of the inability of Randall L. Christian, Esq. to be in attendance.
7. Randall L. Christian, Esq. must, within ten (10) days, pay the fees required by *R. 1:20-1 (b)* and *R. 1:28-2* and submit an affidavit of compliance.
8. *Pro hac vice* admission will automatically terminate for failure to make the initial and any annual payment required by *R. 1:20-1 (b)* and *R. 1:28-2*.
9. Non-compliance with any of the terms of this order shall constitute grounds for removal.

10. A copy of this Order shall be served on all parties within seven (7) days of the date hereof.
