2. Mary R. Pawelek, Esq. shall, and hereby does, consent to the appointment of the Clerk of the Supreme Court as her agent upon whom service of process may be made for all actions against Mary R. Pawelek, Esq. that may arise out of her participation in these matters.

3. Mary R. Pawelek, Esq. shall immediately notify the court of any matter affecting her standing at the Bar of any other jurisdiction.

4. Mary R. Pawelek, Esq. shall have all pleadings, briefs and other papers filed with the court signed by an attorney of record authorized to practice in New Jersey, who shall be held responsible for them, the conduct of the litigation and the attorney admitted herein.

5. Mary R. Pawelek, Esq. cannot be designated as trial counsel.


6. No discovery, motion, trial or any other proceeding delay shall occur or be requested by reason of the inability of Mary R. Pawelek, Esq. to be in attendance.

9. Non-compliance with any of the terms of this order shall constitute grounds for removal.
