**ORDER GRANTING  
PRO HAC VICE ADMISSION OF  
STEPHANIE REEDY, ESQ.**

THIS MATTER having been brought before the Court by way of motion of Hardin, Kundla, McKeon & Poletto, PA counsel for Defendant Northstar Rx, LLC, upon notice to all interested parties, for an order granting *pro hac vice* admission of Stephanie Reedy, Esq.; the Court having considered the papers submitted in support thereof; and the Court having found that Stephanie Reedy, Esq. is a member in good standing of the bar of the highest Court in the State where she is domiciled and principally practices law; and for other good cause shown,

IT IS, on this 26 day of March, 2012;

ORDERED that the motion is granted, and Stephanie Reedy, Esq. is admitted to practice *pro hac vice* before this Court, pursuant to R. 1:21-2, for all purposes and in all proceedings in the same manner as an attorney who is admitted to practice in this State and is domiciled and maintains an office for the practice of law in the State of New Jersey, provided that she shall:

1. abide by the Rules of the Court for the State of New Jersey, including all disciplinary rules;

2. consent to the appointment of the Clerk of the Supreme Court as an agent upon whom service of process may be made for all actions against her or her firm that may arise out of her participation in these cases;

3. notify the Court immediately of any matter affecting her standing at the bar of any Court; and

4. have all pleadings, briefs, and other papers filed in this Court signed by an attorney-at-law of this Court employed by the firm of Hardin, Kundla, McKeon & Poletto, PA who shall be responsible for them, and for the conduct of Stephanie Reedy, Esq.

IT IS FURTHER ORDERED that Stephanie Reedy, Esq. shall make payment of all fees due to the State of New Jersey within 30 days of the entry of this *pro hac vice* Order allowing for admission and as provided in the New Jersey Rules of Court, R. 1:20-1(b), 1:28-2, and 1:28B-1(e); and

IT IS FURTHER ORDERED that the Clerk of the Court shall forward a copy of this Order to the Treasurer of the New Jersey Fund for Client Protection; and

IT IS FURTHER ORDERED that a copy of this Order shall be served by the attorneys for Defendant upon all parties within seven (7) days of their receipt thereof.
