**ORDERED** that Leslie M. Stewart, Esquire shall each make payment of fees as provided in the New Jersey Rules of Court, R. 1:28-1(b) and 1:28b(e) and it is further

**ORDERED** that the Clerk of this Court shall forward a copy of this Order to the Treasurer of the New Jersey Fund for Client Protection; and it is further
