
IT IS, on this 11th day of April, 2014, hereby **ORDERED** as follows:

Plaintiff Fact Sheet - Core Criteria

The parties have agreed that the Plaintiff Fact Sheet contains the following "Core Criteria Categories." Should a plaintiff fail to provide any Answer to any one or more of the questions delineated below and no response of any type is provided within thirty (30) days to a "Deficiency Letter" from Defendant with regards to the following Core Criteria question(s), their Complaint shall be subject to a Motion to Dismiss per Section V of Case Management Order No. 3:

- 1.) SECTION II – PERSONAL INFORMATION ABOUT THE MIRENA USER-, Question 15

- 2.) SECTION III – HEALTHCARE PROVIDERS AND PHARMACIES, Questions 1, and 2.
This includes identification of :
 1. All OB/GYN Providers
 2. Hospitals or clinics where OB/GYN Services rendered
- 3.) SECTION VII - PREGNANCY RELATED CLAIM INFORMATION, , Question 1 –
- 4.) SECTION XI – MIRENA USE - Identification of Mirena Prescribing and/or Inserting Healthcare Provider –, Question 1.) a and b
- 5.) SECTION XI – MIRENA USE - Date of Mirena removal - Question 1(c)
- 6.) SECTION XI – MIRENA USE - Responses to Questions 2 through 10 relating specifically to Mirena insertion, follow-up, and information given at time of insertion and the product.
- 7.) SECTION XII – INJURIES AND DAMAGES– QUESTIONS 1 and 2, including the subparts identified below where an affirmative response is given– pertaining specifically to
 - a. 1. – what physical injuries are claimed as a result of Mirena – including subpart (a) and
 - b. 2 – what mental psychological or emotional injuries are claimed as a result of Mirena – including subpart (a), (c) and (e)
- 8.) SECTION XIV – DOCUMENT DEMANDS - Fully and properly executed medical and insurance authorizations pursuant to SECTION XIV, which includes:
 - a. checking the box for the Release of HIV-Related Information
 - b. a signature
