AND NOW, this 25th day of October, 2018, it is hereby


ORDERED as follows:

1. On October 11, 2018, Amended Case Management Order No. 57 (“CMO 57”) was issued, which required that any and all Non-Responsive Plaintiffs, as defined in CMO 57, who wish to either participate in the settlement in this matter as referred to in CMO 57, or decline to so participate but wish to continue to litigate their claims against one or more of the following Defendants: Bayer HealthCare Pharmaceuticals Inc., Bayer Oy and Bayer Pharma AG (“Bayer Defendants”), including those claims asserted in *In Re: Mirena Litigation*, Multi-County Litigation Case No. 297 pending in the Bergen County Law Division of the Superior Court of New Jersey (“MCL”), file and serve Notices of Intent to Proceed as provided for in CMO 57.
2. Moreover, CMO 57 further provided that unless counsel for any of the Plaintiffs that have not filed and served a Notice of Intent to Proceed as required by CMO 57

(and as identified in the list of such plaintiffs submitted to the Court) or, alternatively, any of the Plaintiffs themselves, appears in Judge Harz's Courtroom on October 19, 2018 at 2:00 p.m. EST and shows cause why the Court should not issue an Order for Dismissal with Prejudice, the Court will consider such Non-Responsive Plaintiffs who fail to appear to have abandoned her/his case and will dismiss with prejudice, the Non-Responsive Plaintiffs' Claims at that time.

3. Accordingly, the claims of Plaintiffs who have failed to file and serve a Notice of Intent to Proceed as provided for in CMO 57 and have failed to appear in Judge Harz's Courtroom on October 19, 2018, such Plaintiffs being identified in the list attached hereto as "Exhibit A," be and are hereby dismissed, with prejudice.
