#### ORDERED as follows:

- 1. On November 1, 2018, Case Management Order No. 60 ("CMO 60") was issued, which required that any and all Deficient Plaintiffs, as defined in CMO 60, who wish to participate in the settlement in this matter as referred to in CMO 60, cure any deficiencies in their Settlement Materials, as defined in CMO 60, by virtue of a procedure for curing such deficiencies outlined in more detail in CMO 60.
- 2. Moreover, CMO 60 further provided that unless counsel for any of the Plaintiffs that have not cured the deficiencies in the Settlement Materials as required by CMO 60 (and as identified in the list of such plaintiffs submitted to the Court) or, alternatively, any of the Plaintiffs themselves, appeared in Judge Harz's Courtroom on November 13, 2018 at 11:00 a.m. EST and showed cause why the Court should not issue an Order for Dismissal with Prejudice, the Court would consider such



Deficient Plaintiffs who fail to appear to have abandoned her/his case and would dismiss with prejudice, the Deficient Plaintiffs' Claims at that time.

3. Accordingly, the claims of Plaintiffs who have failed to cure the deficiencies in their Settlement Materials, as more fully described in CMO 60 and the exhibits thereto and, further, and who failed to appear in Judge Harz's Courtroom on November 13, 2018, such Plaintiffs being identified in the list attached hereto as "Exhibit A," be and are hereby dismissed, with prejudice.
