**CONSENT ORDER FOR ADMISSION
PRO HAC VICE**

This matter having been opened to the Court by Maureen V. Abbey, a New Jersey attorney with the law firm Heninger Garrison Davis, LLC, and attorneys for Plaintiffs listed on Exhibit A having complaints filed in the *In Re Mirena Litigation*, Case no. 297, having Master Case no. BER-L-4098-14, and requesting to admit William L. Bross and Amanda S. Williamson as *pro hac vice* counsel for Plaintiffs, and with the consent of Defendants' counsel, states the following:

And it appearing that William L. Bross and Amanda S. Williamson are attorneys with the law firm Heninger Garrison Davis, LLC, and are admitted to practice law in the State of Alabama,

And it further being stated that William L. Bross and Amanda S. Williamson seek admission *pro hac vice* to this Honorable Court to participate with counsel for Plaintiffs listed in Exhibit A in all phases of the trial(s),

And it further appearing that William L. Bross and Amanda S. Williamson are licensed attorneys in good standing in the State of Alabama, and no disciplinary actions have been initiated, nor are pending,

And it further appearing that William L. Bross and Amanda S. Williamson have had an attorney-client relationship with the Plaintiffs identified in Exhibit A for an extended period of time, and it is important to the interest of the Plaintiffs that William L. Bross and Amanda S. Williamson be permitted to appear and participate as co-counsel because they are each familiar with the law, facts and procedures relating to the subject matter of this litigation.

It is on this 25 day of July, 2014

ORDERED that William L. Bross and Amanda S. Williamson be and are hereby admitted *pro hac vice* and are authorized to appear and participate with other counsel for Plaintiffs listed in Exhibit A in all phases of the trial, subject to the following conditions:

1. William L. Bross and Amanda S. Williamson shall abide by the New Jersey Court Rules including all disciplinary rules, R. 1:20-1 and R. 1:28-2.
2. William L. Bross and Amanda S. Williamson shall, and hereby does, consent to the appointment of the Clerk of the Supreme Court as his/her agent upon whom service of process may be made for all actions against William L. Bross and Amanda S. Williamson, that may arise out of his/her participation in this matter.
3. William L. Bross and Amanda S. Williamson shall immediately notify the court of any matter affecting his/her standing at the Bar of any other jurisdiction.

4. William L. Bross and Amanda S. Williamson shall have all pleadings, briefs and other papers filed with the court signed by an attorney of record authorized to practice in New Jersey, who shall be held responsible for them, the conduct of the litigation and the attorney admitted herein.

5. William L. Bross and Amanda S. Williamson cannot be designated as trial counsel.


6. No discovery, motion, trial or any other proceeding delay shall occur or be requested by reason of the inability of William L. Bross and Amanda S. Williamson to be in attendance.

7. William L. Bross and Amanda S. Williamson must, within ten (10) days of this Order, pay the fees required by R. 1:20-1(b) and R. 1:28-2, and submit an affidavit of compliance.

8. *Pro hac vice* admission will automatically terminate for failure to make the initial and any annual payment required by R. 1:20-1(b) and R. 1:28-2.

9. Non-compliance with any of the terms of this Order shall constitute grounds for removal.

And it is further ORDERED that a copy of this Order shall be served on all counsel within seven (7) days from the date of entry.




Counsel for Defendant consents to Plaintiff's request for admission *pro hac vice* of William L. Bross and Amanda S. Williamson.
