**ORDERED** as follows,

**THAT** Matthew R. McCarley, Esq., be hereby admitted *pro hac vice* in the above captioned matter, pursuant to Rule 1:21-2; and

**THAT** Matthew R. McCarley, Esq., shall abide by the New Jersey Court Rules including all disciplinary rules; and

**THAT** Matthew R. McCarley, Esq., shall consent to the appointment of the Clerk of the Supreme Court as agents upon whom service of process be made for all actions against his firm that may arise out of their participation in this matter; and

**THAT** Matthew R. McCarley, Esq. shall notify the court immediately of any matter affecting his standing at the bar of any other court; and

**THAT** Matthew R. McCarley, Esq. shall have all pleadings, briefs and other papers filed with the court signed by Catherine T. Heacox, Esq. as an attorney of record who is authorized to practice in this State, and who shall be held responsible for him and the conduct of the cause and of attorney Matthew R. McCarley, Esq.; and

**THAT** Matthew R. McCarley, Esq. shall within ten (10) days of the date of this Order comply with Rule 1:20-1(b), Rule 1:28B-1(e) and Rule 1:28-2 and shall submit an affidavit of compliance; and

**THAT** no adjournment or delay in discovery, motions trial or any other proceeding will be requested by reason of Matthew R. McCarley, Esq.'s inability to appear; and

**THAT** automatic termination of *pro hac vice* admission of Matthew R. McCarley, Esq. shall occur for failure to make initial and any annual payment required by

**THAT** noncompliance with any of these requirements shall constitute grounds for removal; and Rule 1:20-1 (b) and Rule 1:28-2.

**THAT** a copy of this Order shall be served on all parties within seven (7) days of the date of this Order.
