(1) Margaret M. Metzinger shall abide by the Rules Governing the Courts of the State of New Jersey, including all Disciplinary Rules, R. 1:20-1 and R. 1:28-2;

(2) Margaret M. Metzinger, and hereby does, consent to the appointment of the Clerk of the Supreme Court as his agent upon whom service of process may be made for all actions against him or his firm that may arise out of his participation in this matter;

(3) Margaret M. Metzinger shall immediately notify the Court of any matter affecting his standing at the Bar of any other jurisdiction;

(4) Margaret M. Metzinger shall have all pleadings, briefs and other papers filed with this Court signed by an attorney of record authorized to practice in New Jersey, who shall be held responsible for them, the conduct of the litigation, and Margaret M. Metzinger, the attorney admitted herein;

(5) Margaret M. Metzinger cannot be designated as trial counsel;

(6) No discovery, motion, trial or any other proceeding delay shall occur or be requested by reason of the inability of Margaret M. Metzinger to be in attendance;

(7) Margaret M. Metzinger must, within ten (10) days, pay the fees required by R. 1:20-1(b) and R. 1:28-2 and submit an affidavit of compliance;

(8) *Pro hac vice* admission will automatically terminate for failure to make the initial and any annual payment required by R. 1:20-1(b) and R. 1:28-2;

(9) Non-compliance with any of the terms of this order shall constitute grounds for removal; and it is further

ORDERED that a copy of this Order shall be served upon all parties within seven (7) days from the date hereof.
