IT IS on this 18<sup>th</sup> day of April, 2017,

**ORDERED** that Bard's Motion for the Admission of Eric L. Alexander, Esq., *pro hac vice* is hereby **GRANTED**; and it is

**FURTHER ORDERED** that Eric L. Alexander, Esq. of Reed Smith LLP 1301 K Street, N.W., Suite 1000-East Tower, Washington, D.C., 20005, be and hereby is, admitted *pro hac vice* to

the bar of the Supreme Court of the State of New Jersey for the purpose of representing Bard before this Court in the *Rios* matter, BER-L-018689-14; and it is

**FURTHER ORDERED** that Eric L. Alexander, Esq. shall:

1. Abide by the New Jersey Rules of Court, including all disciplinary rules;
2. Consent to the appointment of the Clerk of the Supreme Court as agent upon whom service of process may be made for all actions against him that may arise out of his participation in this matter;
3. Notify the Court immediately of any matter affecting his standing at the bar of any court; and
4. Have all pleadings, briefs and other papers filed with the Court signed by an attorney of record authorized to practice in New Jersey, who shall be responsible for him and for the conduct of the cause; and it is



**FURTHER ORDERED** that Eric L. Alexander, Esq. will make all required payments to the New Jersey Fund for Client Protection within 10 days hereof and shall annually comply with R. 1:20-1(b) and R. 1:28-2(a) during the period of his admission; and it is

**FURTHER ORDERED** that a copy of this Order shall be served upon all counsel within seven (7) days of the date of this Order.
