FURTHER ORDERED that Jesse J. Ash, Esq. of Reed Smith LLP 1301 K Street, N.W., Suite 1000-East Tower, Washington, D.C., 20005, be and hereby is, admitted *pro hac vice* to the bar of the Supreme Court of the State of New Jersey for the purpose of representing Bard before this Court in the *Moore* matter, BER-L-18156-14; and it is

1. Abide by the New Jersey Rules of Court, including all disciplinary rules;
2. Consent to the appointment of the Clerk of the Supreme Court as agent upon whom service of process may be made for all actions against him that may arise out of his participation in this matter;
3. Notify the Court immediately of any matter affecting his standing at the bar of any court; and
4. Have all pleadings, briefs and other papers filed with the Court signed by an attorney of record authorized to practice in New Jersey, who shall be responsible for him and for the conduct of the cause; and it is


FURTHER ORDERED that the admission of Jesse J. Ash, Esq. is subject to any conditions imposed by the judge hearing the trial of this matter; and it is

FURTHER ORDERED that the admission of Jesse J. Ash, Esq. shall not in any way delay the trial of this matter, nor serve as the basis for any application for adjournment of trial of this matter; and it is

FURTHER ORDERED that Jesse J. Ash, Esq. will make all required payments to the New Jersey Fund for Client Protection within 30 days hereof and shall annually comply with R. 1:20-1(b) and R. 1:28-2(a) during the period of his admission; and it is

FURTHER ORDERED that a copy of this Order shall be served upon all counsel within seven (7) days of the date of this Order.
