THIS MATTER having come before the Court on the application of Adam M. Slater, Esq., attorney for the Plaintiffs and the Court having reviewed the papers filed herein, and for good cause shown, namely that the matters involve a complex area of law and that Jeffrey M. Kuntz, Esq. is a specialist,

IT IS on this 28 day of Sept, 2012,

ORDERED as follows:

THAT Jeffrey M. Kuntz, Esq. be hereby admitted *Pro Hac Vice* in the matters listed in the attached Schedule A, pursuant to R. 1:21-2; and

THAT Jeffrey M. Kuntz, Esq. shall abide by the New Jersey Court Rules including all disciplinary rules; and

THAT Jeffrey M. Kuntz, Esq. shall consent to the appointment of the Clerk of the Supreme Court as an agent upon whom service of process may be made for all actions against him that may arise out of his participation in this matter; and

THAT Jeffrey M. Kuntz, Esq. shall notify the Court immediately of any matter affecting his standing at the bar of any other Court; and

THAT Jeffrey M. Kuntz, Esq. shall have all pleadings, briefs and other papers filed with the Court signed by Adam M. Slater, Esq., or another attorney of record who is authorized to practice in this State, and who shall be held responsible for them and the conduct of the cause and of attorney Jeffrey M. Kuntz, Esq.; and

THAT Jeffrey M. Kuntz, Esq. shall within ten (10) days of the date of this Order comply with R. 1:20-1(b), R. 1:28-2 by paying the appropriate fees to the Oversight Committee, to the Lawyer's Assistance Fund and the New Jersey Lawyer's Fund for Client Protection no later than February 1st of each year thereafter and shall submit an affidavit of compliance; and

THAT Jeffrey M. Kuntz, Esq. shall not be designated as trial counsel; and

THAT no adjournment or delay in discovery, motions, trial or any other proceeding will be requested by reason of Jeffrey M. Kuntz's, Esq. inability to appear; and

THAT automatic termination of *Pro Hac Vice* admission of Jeffrey M. Kuntz, Esq. shall occur for failure to make the required annual payment of the Annual Fee and the annual payment to the Lawyer's Assistance Fund and the New Jersey Lawyer's Fund for Client Protection. Proof of such payment, shall be made no later than February of each year; and

THAT noncompliance with any of these requirements shall constitute grounds for removal; and

THAT a copy of this Order shall be served on all parties within seven (7) days of the date of this Order.
