**ORDER ON BARD'S MOTIONS FOR PROTECTIVE ORDERS AND TO (i)
QUASH PLAINTIFFS' NOTICES IN LIEU OF SUBPOENA and (ii) QUASH
NOTICE OF DEPOSITION FOR CORPORATE DESIGNEES**

THIS MATTER having been opened to the court by C.R. Bard, Inc. ("Bard") on its motions for protective orders and to quash Plaintiffs' notices in lieu of subpoenas and notice of deposition for corporate designees ("Motions") in the above-captioned matter, and the court having heard oral argument, and for the reasons set forth on the record on February 28, 2018, and for other good cause shown;

IT IS ORDERED on this 1st DAY of MARCH, 2018, as follows:

1. As to the financial information sought by Plaintiffs from Bard, the parties are directed to attempt to work out a stipulation as to the requested financial

information. In the event the parties are unable to reach such agreement by the close of business on March 5, 2017, the court will consider the arguments and enter an order without further submissions or oral arguments from the parties.

2. Bard's motion to quash the notice in lieu directed to John Weiland is GRANTED.


3. Bard's motion to quash the notice in lieu directed to Adam Silver is DENIED.

4. Bard's motion to quash the notice in lieu directed to Gary Teague is DENIED as moot since Plaintiffs advised they do not intend to call Mr. Teague as a witness in their case in chief.

5. Bard's motion to quash the notice in lieu as to a Bard representative with regard to Bard's membership in and contributions to and sponsorships of AUGS, ACOG, SUFU, AUA and Alva Med is GRANTED.

6. Bard's motion to quash the notice in lieu as to a Bard representative for the purpose of authenticating Bard documents is DENIED as moot since Bard advises that it will not raise authentication objections as to Bard's documents.

7. A copy of the order shall be served on all parties within seven (7) days of the date of the order.
