**FURTHER ORDERED** that Marcella C. Ducca, Esq. shall:


1. Abide by the New Jersey Court Rules, including all disciplinary rules;

3. Notify the Court immediately of any matter affecting his standing at the Bar of any other court;
4. Have all pleadings, briefs, and other papers filed with the Court signed by an attorney of record authorized to practice in this State, who shall be held responsible for them, the conduct of the case, and the attorney admitted herein;

**FURTHER ORDERED** that the admission of Marcella C. Ducca, Esq. is subject to any conditions imposed by the judge hearing the trial of this matter; and it is

**FURTHER ORDERED** that the admission of Marcella C. Ducca, Esq. shall not in any way delay the trial of this matter, nor serve as a basis for any application for adjournment of trial of this matter; and it is

**FURTHER ORDERED** that Marcella C. Ducca, Esq. will make all required payments to the New Jersey Fund for Client Protection within \_\_\_\_\_ days hereof and shall annually comply with R. 1:20-1(b) and R. 1:28-2(a) during the period of his admission; and it is
